

# **FENCING ARC FORM ONLY**

**If the Resident is not Home Owner, form must be completed by Home Owner**

## **Instructions**

- 1) **Complete all items on form and sign form.**
- 2) **New or replacing fencing requires an ARC form to be completed.**
- 3) **No material shall be used for fencing that is not masonry, wood, metal, or PVC.**
- 4) **No fence shall exceed a height of six (6) feet.**
- 5) **All fences must be behind the front setback line of dwelling.**
- 6) **Fence material must be given on ARC form.**
- 7) **Diagram of lot with all fence positioning must be attached to ARC form.**
- 8) **ARC form must be approved prior to commencement of any work.**
- 9) **Please allow 30 days for form approval.**
- 10) **Inspection by ARB will be in 30 days from work commencement date.**
